



TEMPORARY FOOD EVENT NOTIFICATION

REQUIREMENT TO NOTIFY

Food businesses, including those involved in temporary events in NSW, are required to notify their food activity details to the relevant enforcement agency, unless exempt. This requirement is imposed by the *Food Act 2003 (NSW)*.

The notification form must be completed and submitted to Council for approval two weeks prior to the scheduled event.

FOOD SAFETY SUPERVISOR (FSS)

Certain hospitality and retail food businesses in NSW are required to have at least one trained and appointed FSS. Businesses must also keep a copy of their certificate on the premises at all times to show inspectors. Temporary food businesses can refer to www.foodauthority.nsw.gov.au for further details.
